### Goal of Plan

Provide Educational Opportunities to all students and families who are able and willing to engage, both electronically and through paper copy.

#### Overview of Plan

#### CONTINUITY OF EDUCATION: SHORT-TERM PLAN

- ➤ Beginning with the Governor's announcement of Montgomery County closures,, teachers and administrators have been organizing and preparing material for your students to complete.
- At the end of the day Friday (March 27), we will be shutting down the public enrichment page featured on our website, as we will be offering students activities which may require licensing and/or copyrighted material.
- On Monday morning (March 30), teachers and educational staff will contact students/families with organized review and enrichment activities based on material from the classroom. This will not include new curriculum material at this stage of the plan. However, there will be resources and activities to help students and we highly encourage all students & families to treat the activities provided seriously. We are designing the activities to be "user friendly," engaging and not difficult to complete.
- ➤ Pre-k through 6th grade will receive one (1) Language Arts and one (1) Math activity per day until spring break, which begins Thursday, 4/9/20. With the closure extended, we plan to move to a model of advancing curriculum.
- > 7th-12th grades will receive activities based on student course: English, Math, Science, Social Studies, etc..

- ➤ Counseling services will be made available to those who were previously using them. Mental Health is still critically important, and our counselors will be available to the extent this crisis allows.
- ➤ Teachers will be available for support at certain times, both in the morning and afternoon, each day we would otherwise be open. They will communicate specific times.
- > Special Education teachers, ESL teachers and related service providers will be reaching out to families to support students in multiple ways.
- ➤ Look for correspondence from teachers through email, Class Tag (Middle School), Google Classroom (High School), or other previously used communication platforms this Monday 3/30/20.

☐ High School students were issued chrome devices in September 2019. They will begin new instruction 4-20-20

- ☐ Middle School is scheduled to begin New instruction 4-27-20
- ☐ Elementary School is scheduled to begin New instruction 5-4-20
- ☐ All teachers will be trained in Google Educator Training series
- ☐ All teachers will use the Google Classroom and the Google platform for distance learning.
- On 4-16-2020, there will be a technology distribution of hotspots and devices to over 300 households and 500 students. Each household will receive 1 device per 2 students.
- We are ordering a device for every student 1st through 8th grade, since so many students need devices or the internet, or both. This is not including devices we already have at the middle and elementary levels.

# Special Education/504 Supports

#### IEPs/GIEP

NOREPs will be issued for each student who receives services under IDEA and Chapter 14. Special education teachers/gifted teachers, school counselors, nurses and speech therapists will continue writing IEPs/504s and will hold virtual IEP meetings to ensure FAPE.

Psychologists will continue completing ERs and RRs. All reports will be finalized with a statement alerting the parent to the fact that at this time we are not able to complete the report due to the lack of access to the student for testing. All ERs and RRs will be finalized and a statement will be included that a PTE or PTRE will be sent upon return to school to finish the assessments. A new timeline of 60 days will be in place. If the psychs feel that they have enough information to complete the ER or RR without needing additional information, they will complete the ER and/or RR as usual. If the psychs feel that they have enough information to make a conclusion pertaining to the students eligibility, but they still require additional information, they will conclude that the student is eligible for services, but additional testing will be required upon returning to school. If the psychs feel that they do not have enough information to make a conclusion, they will state that they are not able to make a conclusion at this time and testing will resume upon returning to school. Special Education teachers will continue to progress monitor students per their IEP Goals. Special Education Teachers Who Teach Direct Instruction Only:

Special education teachers who teach direct instruction will provide one enrichment activity a day for the students on their caseload who requires that level of service. The special education teacher may decide to complete math, reading, writing, social skills, and behavior skills activity depending on the needs of their students. They may use Google Hangout, Zoom, Videos or Google Classroom, sending resources, youtube or any combination of aforementioned. Direct instruction teachers can provide support to general education teachers for accomodations; however this should be limited as they are creating 5 plans a week and will be required to have office hours two times a day for up to one hour depending on the number of students on their caseload. The accommodations that will be provided will be a generic list of accommodations from the most intense to the least intense with the students and parents determining which accommodations are necessary for the student to complete the activities. The general education teachers may also elect to assign which accommodations individual student should use based on the student's individual IEP and SDI. Teachers will reach out to parents to let them know the times of the online enrichment if necessary and the times for office hours.

Special Education Teachers Who Do Not Teach Using Direct Instruction Model
Special Education Teachers who do not teach direct instruction to students will support the general
education teachers by providing accommodations and or modifications for enrichment activities for
special education students. They will also provide office hours two times a day for up to one hour
each to help students complete enrichment activities provided by the general education teachers.

Special Education Teachers Who Teach Both Direct Instruction and Itinerant Students
The main priority will be developing enrichment activities for students who receive DI; 5 activities a
week. The special education teacher may decide to complete math, reading, writing, social skills,
and behavior skills activity depending on the needs of their students. They may use Google Hangout,
Zoom, Videos or Google Classroom, sending resources, youtube or any combination of
aforementioned. They will support general education teachers as necessary to provide
accommodations noting that their priority will be direct instruction students. They will offer two
times a day for office hours up to one hour each depending on the needs of students. They will
contact the parents to let them know what times they will be conducting live activites if necessary
and alerting them to their office hours.

# **EL Supports**

ESL Teachers will be providing enrichment activities for students at the different proficiency levels for elementary, middle, and high school. Non ESL Teachers will be inserting a link into their lessons for Google Translate so parents have fair and equitable access to all directions and materials. ESL Teachers will continue to make every effort to contact parents- through email (if accessible), an interpreter, or by using Transperfect.

#### Gifted Education

Elementary and Middle School Gifted students will be able to access enrichment resources on a Google Classroom site created for each specific grade level. They will be able to reference and/or download resources as necessary from the classwork tab on the site and ask questions or receive feedback on the stream tab on the site. All work will be able to be turned in on the site or via email.
